The Art, Design and Technology Faculty

The faculty covers a wide range of subjects including Art, Textiles, Food and Nutrition, Resistant Materials and Design

Food and Nutrition is taught to all pupils at KS3 as part of the Art, Design and Technology carousel. At KS4 Food and Nutrition is on offer through the options process.

The team

The faculty is made up of a team of six teaching staff currently, and are supported by an outstanding technician. We have five dedicated art and design technology rooms that are well equipped.

The Food and Nutrition classroom was fully refurbished six years ago and accommodates 14 cookers in a modern, spacious, flexible classroom layout.

Key Stage 3

Art, Food, Resistant Materials, Textile and Design Technology are taught on a carousel system at Key Stage 3. Class sizes are around 22-24 students at Key Stage 3

Each module is taught for one double lesson each week, for twelve weeks during the year. This gives students a broad range of experiences before specialising at KS4.

Key Stage 4

Food and Nutrition is offered as part of the options process at KS4 and is a popular options choice. Each option group is taught for one 100 minute and one 50 minute lesson each week.

Food Technology follows the OCR GCSE specification

To implement and deliver an appropriately broad, balanced, relevant and differentiated curriculum for students and to support a designated curriculum area as appropriate. To monitor and support the overall progress and development of students as a teacher / form tutor. To facilitate and encourage a learning experience which provides students with the opportunity to achieve their individual potential. To contribute to raising standards of student attainment. To share and support the school's responsibility to provide and monitor opportunities for personal and academic growth.

2. TEACHING

- To undertake a designated programme of teaching.

- To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students.
- To ensure that ICT, literacy, numeracy, work-related learning and other whole-school themes are reflected in the teaching/learning experience of students.
- To ensure a high quality learning experience for students which meets internal and external quality standards.
- To prepare and update subject materials.
- To use a variety of delivery methods which will stimulate learning appropriate to student needs and demands of the syllabus.
- To maintain discipline in accordance with the school's procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework.
- To undertake assessment of students as required by external examination bodies, faculty and school procedures.
- To mark, grade and give written/verbal feedback.
- To ensure the effective/efficient deployment of classroom support.
- To contribute to the moral and spiritual development of each student in line with our ethos as a Church of England school.

3. OPERATIONAL/ STRATEGIC PLANNING:

- To assist in the development of appropriate syllabuses, resources, schemes of work, marking policies and teaching strategies in the Curriculum Area.
- To contribute to the subject team's development plan and its implementation.
- To fully plan and prepare courses and lessons.

4. **CURRICULUM PROVISION:**

• To assist the Head of Faculty, to ensure that the curriculum area provides a range of teaching which complements the school's strategic objectives.

5. CURRICULUM DEVELOPMENT:

• To assist in the process of curriculum development and change so as to ensure the continued relevance to the needs of students, examining and awarding bodies and the school's mission and strategic objectives.

6. PROFESSIONAL DEVELOPMENT:

- To take part in the school's staff development programme by participating in arrangements for further training and professional development.
- To participate in whole-school training, making links with teaching styles and approaches in other subjects.
- To continue personal development in the relevant areas including subject knowledge and teaching methods.
- To engage actively in the performance management review process.
- To work as a member of a designated team and to contribute positively to effective working relations within the school.

7. STANDARDS:

- To contribute to the process of monitoring and evaluation of the curriculum area/faculty in line with agreed school procedures, including evaluation against quality standards and performance criteria.
- To use targets and data to provide students with challenging but attainable targets in their work.
- To review and record student progress regularly.
- To seek/implement modification and improvement in the curriculum and learning & teaching approaches where required.
- To set and assess homework in line with subject and whole-school guidelines.

8. MANAGEMENT INFORMATION:

- To maintain appropriate records and to provide relevant accurate and up-to date information for MIS, registers, etc.
- To complete the relevant documentation to assist in the tracking of students.
- To track student progress and use information to inform teaching and learning.

9. COMMUNICATION & LIAISON:

- To communicate effectively with the parents of students as appropriate.
- Where appropriate, to communicate and co-operate with persons or bodies outside the school.
- To follow agreed policies for communications in the school.
- To take part in liaison activities such as parents' evenings, review days and liaison events with partner schools.

- To apply the school's house style on behaviour management so that effective learning can take place.
